


Order

Whereas General Elections to Lok Sabha constituencies falling in the State of Haryana are scheduled to be held on 25.05.2024 and counting of votes is scheduled to be held on 04.06.2024. In this regard, the Election Commission of India has directed that no liquor shops, hotels, restaurants, clubs and other establishment's selling/serving liquor, shall be permitted to sell/serve liquor to anyone whatsoever on polling days. Therefore, I, Ashok Kumar Meena, IAS, Excise Commissioner, Haryana, Panchkula in pursuance of the provisions of rule 37(10) of the Haryana Liquor License Rules, 1970 hereby order that the liquor vends located in the State of Haryana shall remain closed during the period of Forty Eight (48) hours ending with the hour fixed for the conclusion of poll and on the day of Counting i.e. 04.06.2024 till the counting is over.

I further order that the restriction prescribed in the excise laws on possession and storage of liquor in unlicensed premises shall be vigorously enforced in order to ensure that storage of liquor by individuals is drastically reduced during the aforementioned period.






